Air-Source Heat Pumps

Required: At least 7.5 HSPF2, 15.2 SEER2

Rebate: \$150 per ton

Noble REMC air-source heat pump rebates cannot be combined with any other rebate programs, including POWER MOVES®, featured on the other side of this info sheet. Copies of the invoice(s) for the new equipment must be sent in with the application, and all invoices must be marked "paid" or show a zero balance. A copy of the Air Conditioning, Heating and Refrigeration Institute (AHRI) certificate and a copy of the heat loss/heat gain calculation must also be included. For full requirements, see application. Water Heaters

If you buy through Noble REMC, you'll receive an **AO Smith electric water heater** below our cost.
(Call our office for pricing.)

If the water heater is being installed in a new home, there's NO CHARGE for the water heater.

If you're going from gas to electric, you'll receive a \$150 installation and wiring allowance.*

Simply changing out your old electric water heater?

You're still eligible for a \$100 installation allowance.*

We also provide a **\$100 annual maintenance allowance** for the cost of labor and parts on the electric heating units, and honor a six-year tank and parts warranty.

Heat pump water heaters are also available,

with the purchase being eligible for an additional \$800 Power Moves rebate!

If it's being installed in a new home, you will receive a \$150 discount,

as well as a discount equal to the cost of a 50-gallon standard electric water.

Apply these incentives, and you've slashed the price to less than half of a standard water heater!
